**COUNT ONE**

(18 U.S.C. § 2252A(a)(5)(B)-- *Possession of Child Pornography*)

D-1 MATTHEW BROWN

On or about December 3, 2009, in the Eastern District of Michigan, MATTHEW BROWN, defendant herein, did knowingly possess any matter that contained an image of child pornography, as defined in Title 18, United States Code, Section 2256(8), that had been mailed, shipped and transported in interstate and foreign commerce by any means, including by computer, and that was produced using materials that had been mailed, shipped, and transported

in interstate and foreign commerce by any means, including by computer, all in violation of 18 United States Code, Section 2252A(a)(5)(B).


